

Privacy Policy

INTRODUCTION

Learn and Inspire Limited is responsible for protecting your personal information. This policy explains what information we collect about you and how we control, process and handle it. The privacy policy applies to information obtained via our website and or booking processes.

If you do not agree to the following policy, you may wish to cease viewing/using our website and or refrain from submitting your personal data to us. Under data protection laws (the General Data Protection Regulation (Regulation (EU) 2016/679) (GDPR) as well as any other implementing legislation, including the Data Protection Act 2018 the company responsible for your personal information is Learn and Inspire Limited. This means that Learn and Inspire Limited determines the purpose for which, and the manner in which, your data is processed.

This Privacy Policy applies only to actions Learn and Inspire Limited and users with respect to this website. COLLECTION OF PERSONAL INFORMATION AND HOW WE COLLECT IT

The information collected by Learn and Inspire Limited could be used to identify you. Personal information such as your name, email address, telephone number, postal address and employment information are collected with your consent. Learn and Inspire Limited collect information you voluntarily provide either through the website, telephone or via email when booking with us or contacting us.

AUTOMATICALLY COLLECTED DATA

When you access our website, we automatically collect your data for example: we automatically collect some information about your visit to the website. USE OF YOUR PERSONAL DATA

For other types of e-marketing, we are required to obtain your explicit consent; that is, you need to take positive and affirmative action when consenting by, for example, checking a tick box that we'll provide.

We will share your data with the following groups of people for the following reasons:

Nuco Training, as they are the approved centre for the First Aid for Mental Health Courses. In order to receive the certificate, the information we need to provide them with is your full name.

Aid Training, as they are the certificating body for the First Aid Courses. In order to receive the accredited certificate, the information we need to provide them with is your full name.

DATA SECURITY AND INTEGRITY

Learn and Inspire Limited are committed to taking reasonable and appropriate steps to protect the personal information that we hold from misuse, loss or unauthorised access. All data that is stored is password protected. DATA RETENTION

Unless a longer retention period is required or permitted by law, we will only hold your data for the period necessary to fulfil the purposes outlined in this privacy policy or until you request that the data be deleted. Even if we delete your data, it may persist on backup or archival media for legal, tax or regulatory purposes.

YOUR RIGHTS

You have the following rights in relation to your data:

Right to access – the right to request copies of the information we hold about you at any time, or that we modify, update or delete such information. If we provide you with access to the information, we hold about you, we will not charge you for this, unless your request is "manifestly unfounded or excessive." Where we are legally permitted to do so, we may refuse your request. If we refuse your request, we will tell you the reasons why.

Right to correct – the right to have your data rectified if it is inaccurate or incomplete.

Right to erase – the right to request that we delete or remove your data from our system.

Right to restrict our use of your data - the right to "block" us from using your data or limit the way in which we can use it.

Right to data portability – the right to request that we move, copy or transfer your data.

Right to object - the right to object to our use of your data including where we use it for our legitimate interests.
